

President's Letter

Dear Junior League of Duluth Members,

As we close out our 98th year as a member of the Association of Junior Leagues International (AJLI) and I reflect upon my tenure as the 2018–2019 President of the Junior League of Duluth, I am so proud of all that JLD has embarked upon to ensure another impactful year. Our membership, Active and Sustaining, continued its strong tradition of commitment to voluntarism and the Twin Ports community.

Over the year, JLD continued its Issues Based Community Impact efforts with our food-insecurity focus through our Let It Grow programming. We started the year



celebrating with many community partners the successful completion of a deep winter greenhouse in the Denfeld neighborhood, continued our Provide-a-Pantry efforts at the Harrison Farmers Market, and led numerous community chats to research likely opportunities for new projects and partnerships.

Our membership efforts allowed JLD to grow not only its active member base, but re-engaged former sustainers to return to JLD as well and allowed the development of our members' leadership skills through GMM and AJLI training opportunities. We also had JLD representation at the Association level on a 3-year Food Security Network pilot coalition and had a member appointed to a New Regional Meeting Task Force this spring.

2018–2019 was a successful year financially with our Festival of Trees surpassing fundraising goals by more than \$18,000 and community gift awards of more than \$33,000 were distributed between Community, Endowment and Dale Heimbach Wheeler gifting.

Finally, we were thrilled to kick-off of our JLD Centennial Committee efforts with initial planning well underway. There are so many exciting opportunities for membership to get involved in the coming months and we look forward to promoting our organization, recognizing our volunteers, and celebrating our history.

Impactful. Determined. Unstoppable. Words synonymous with the Junior League of Duluth. We have heard these words describe our work in the community, and our members, for nearly 100 years. This year has been no different. We have continued to build upon our legacy as an organization of UNSTOPPABLE women.

Nominating and Placement

The Nominating Placement Team successfully changed bylaw, Article VIII, Section 3. Nomination. The official wording of the updated bylaw is: Candidates for Council Directors *are recommended to* have served at least one year in an appointed leadership position.

New JLD Office

Renovations to the Lake Superior Area Realtors building resulted in loss of the JLD office space during February 2019, but we were fortunate that arrangements were made to continue holding our meetings in that space and to retain our storage space in the on-site

garage. New office space was found a short drive away in the King Building at 2711 W Superior St., Duluth.

Strategic Plan

JLD continued the 2017-2010 Strategic Plan and worked on the following goal specific action items set forth at the 2018 Board Retreat:

- Goal 1: Enhance Organizational Outreach. Sponsored Duluth
- Chamber's "Ignite Your Fuse" event at Duluth Pack and committed to an August 2, 2019, sponsorship of the Chamber's "Finally Fridays" with Lake Superior Area Realtors. Social media was utilized and updated more frequently leading to increased views and engagements to website and Facebook, especially from new users, demonstrating an effective marketing strategy. Continued to provide pantry items, recipes, and coupons through our Provide a Pantry program. Twelve community partner meetings were held to discuss community needs and potential partnerships. FOT vendor numbers were maximized with an ongoing effort to monitor and maintain high vendor revenue. JLD was featured at The Deep Winter Greenhouse Ribbon Cutting Ceremony through our President's speech, posters and promotional items, and cake!
- Goal 2: Cultivate Strategic Vision. Chamber of Commerce information was listed in E-lights to encourage members who are interested can sign up for notifications. Diversity and inclusion language was included on all community partner communications. Strategic vision discussions were incorporated into our monthly board meetings.
- **Goal 3: Maximize Meeting Effectiveness.** Additional handouts were provided for new members and the presentations were sent out following each class. Celebration of our new office familiarized members with that space and post-GMM meetings were encouraged for all councils.
- Goal 4: Increase Member Engagement. AJLI Webinar Wednesdays were posted on the JLD internal calendar as well as internal Facebook page, and connections were made to other community calendars keeping members informed about events they could attend. Two Done-in-a-Meeting (Life House meals-in-a-bag) and three Done-in-a-Day (Deep-Winter Greenhouse site tree planting, and two First Witness REACH Program dinner service events) were completed. The Community Impact Project has worked to ensure membership engagement and buy-in and an April GMM vote approved ongoing initiatives. Finance Director has provided a JLD budget summary at GMMs to better inform members. New JLD members were featured in League Lights, filled out N/P forms, and were contacted directly for guidance concerning their first placements. The Sustainer/Active Social in August was well attended and JLD mini-directories were distributed at the Fall Sustainer Tea and mailed to those who could not attend. Outreach to

sustainers has been effective with more engagement, leading to two former sustainers rejoining JLD in the past 12 months.

For 2018–2019, the Communications Council focused on several aspects of the strategic plan:

Organizational Outreach

- Increased awareness of JLD brand and activities; for example, marketing through the Chamber reached in excess of 6K and 3K weekly and monthly, respectively, in both electronic and print media
- Sponsored an Ignite Your Fuse luncheon event at Duluth Pack Store in March; committed to sponsorship of a Finally Fridays event in August, 2019
- Completed contract with the Chamber resulting in 12 "Week at a Glance" ads over the course of 2018
- Increase Member Engagement
 - Communicated AJLI Webinar Wednesdays schedule to membership
 - Communicated Chamber networking and educational opportunities afforded to JLD members
 - Advertised New Member Socials and Classes in September and February on the JLD FB page; posts for the September event reached 4K, and the event page had 1.3K views and 104 responses
- Cultivate Strategic Vision
 - Incorporated AJLI diversity and inclusion language and policy into JLD outreach and activities including website, social media and other promotional material
