


- Contacted and coordinated efforts of Nelle Rhicard to work on a history graphic recording for JLD, "Women of Action for Over 100 Years"

 - Managed toffee breaking event details and encouraged Sustainers to sign up for the event as well as FOT

- Involved in First Witness meetings as the organization develops plans for their new, enlarged location to meet increased need in the Duluth community

COUNCIL HIGHLIGHTS

Planning Council

- Attended 2022 AJLI Annual Meeting and 2023 AJLI Winter Forum and participated in the presidency track training sessions. President-Elect worked closely with the current president to learn the responsibilities at each level to ensure continuity and expansion of vision
- Updated JLD Mission Statement to match the newly adopted AJLI Mission Statement which was approved by ballot vote at the General Membership Meeting on January 17.





- JLD hired out FOT responsibilities this year per board decision. JLD did not have a FOT Event Chair or FOT Vendor Chair placed for the 2022.2023 League year.
- The JLD Planning Council worked with the event coordinator to plan and organize the 2022 Festival of Tree's event. The event coordinator also developed written instructions and templates to make it easier to run this event in the future
- Actively engaged with membership by attending events, such as Tie one On blanket tying, New Member Socials, etc
- Actively recruiting a key President Elect position that has not been filled yet for the current year

Membership Council

- Hosted a Yoga/Happy Hour New member event on October 13
- The Fall new member orientation took place on October 20 at the new First Witness Facility; six prospective members were in attendance
- Hosted a Winter new member event at Mix Cosmetiques on Feb 2; the group enjoyed making a salt/sugar scrub and learned more about Junior League
- The new member orientation took place at the original First Witness building. The group toured the facility and learned more about the Junior League and our partnership with First Witness.
